Submissions should be original and complete manuscripts in English and in PDF format. They should begin with a title page that includes the names, e-mail addresses, and affiliations of all authors as well as a 200-word abstract and keywords. A blind PDF copy of the paper should also accompany the submission. All the submitted papers will be reviewed by a panel of Conference Committee Members.
